Subject: - Soil Health Programme: Status Update and Video Conference

Madam/Sir

As you are aware, the Ministry of Agriculture and Farmers' Welfare, in partnership with the Ministry of Education, has launched a nationwide initiative to enhance soil health and agricultural productivity. This program involves engaging students and sensitizing farmers through soil testing and the generation of soil health cards.

While the program has been launched initially in 10 KVs and further expanded to 200 KVs across the country, some KVs have yet not completed all the necessary steps, including soil sample collection, soil health card generation, and conducting gram sabhas led by students.

To assess the progress of the program in the allotted KVs (listed in the enclosed document-10+200), a Video Conference has been scheduled for September 30, 2024, from 11:00 AM to 12.00 noon.

Therefore, it is requested to instruct the Incharges Assistant Commissioner of Region, Principals and Teacher In-charges of the concerned KVs to join the video conference as scheduled.

Further, it is also requested to disseminate the following instruction to the Principals and Teacher In-charges of concerned KVs:

- To join through only one login for the video conference.
- To display their school's name when logging in.
- To keep complete and updated data and records of their school's progress in the soil health program.

Furthermore, officials from the Ministry of Agriculture and Farmers' Welfare will be joining the video conference to provide guidance and address any query.


